B. An Office Visit Fee of \$17 will be charged each time each patient is seen by the Registered Nurse. Only one office visit fee will be charged per patient for same day multiple shots.
C. An \$18.50 vaccine administration fee will be charged for each vaccine given.
D. If you need a Malaria prescription, a SEPARATE appointment must be made with our doctor. When calling for an appointment for travel immunizations, please state that you need a malaria appointment as well.
E. Charges are for each vaccine received by each patient at each visit (see below).
F. Payment is accepted in cash, check, VISA, AMERICAN EXPRESS, MASTERCARD or DISCOVER.
G. Travel Immunizations are not covered by Medicare/Medi-Cal.
H. If you have your immunization records, please bring them with you.

An \$18.50 vaccine administration fee will be charged for each vaccine given.
This fee is in addition to the vaccine prices listed below.
