Startup Direct Incentives*

- [Try-Transit-On-Us](#) – Receive a partial refund for purchasing pass/ticket for the first three months - 75% month one, 50% month two, 25% month three.
- [Start-A-Vanpool](#) - Lease a vanpool vehicle to commute to work with at least three other County/Court employees and get \$300 after three months and another \$300 after six months.
- [Get-A-Charge-on-Us](#) – Lease or purchase an Electric Vehicle (EV) or Plug-in Hybrid Electric Vehicle (PHEV) and get a \$100 incentive.

- [Club Rideshare Registration](#) – Register and track the first 20 rideshare events during a three-month period to get \$40. (Not available in conjunction with certain other Startup Direct Incentives.)

On-going Direct Incentives*

- [Club Rideshare](#) members are eligible to win monthly drawings and other contests. Members receive a special monthly e-Bulletin previewing discounts, alerts and fun things for rideshare participants. Renew annually to receive \$15. Refer-A-Coworker and get \$10 when they join.

Other Local Incentives

- \$2/day Incentive – Gift card payout for first three months of ridesharing (Inland Empire Commuters only, funded by Riverside County Transportation Commission).
- Rideshare Plus – Thank you reward and discounts for continuing to rideshare (Inland Empire only, funded by Riverside County Transportation Commission).
- OCTA Vanpool Subsidy – Reduction in monthly lease amount up to \$400 – Funded by Orange County Transportation Authority.
- Event Discounts – Show Metrolink or OCTA tickets or Transponder to receive discounts from participating vendors.
- 91 Express Lane – Free or discounted fees for carpools or vanpool with three or more people.
- Other special promotions funded by other agencies.

Outreach and Education

- Quarterly *OC Commuter* newsletter distributed electronically to all employees.
- Annual Transportation Survey that includes the opportunity to sign up for the carpool/vanpool ridematch list.
- Program information to employees through new hire orientations and other outreach efforts.
- Rideshare booth at the OCEA Annual Health Fair and other large events.
