**ITEM #1 PUBLIC MEETING – SUPPLEMENT TO FINAL ENVIRONMENTAL IMPACT REPORT (FEIR) NO. 564/IP NO. 08-589 FOR THE JAMES A. MUSICK FACILITY EXPANSION – APPLICANT & OWNER – COUNTY OF ORANGE – LOCATION – 13502 MUSICK DRIVE, IRVINE – DISTRICT 3**

This environmental analysis has been prepared to review and analyze the potential environmental impacts related to the adoption of a Revised Site and Facilities Master Plan for the James A. Musick Facility (Revised Master Plan), as required by the California Environmental Quality Act (CEQA). Proposed Supplement to FEIR No. 564 (Proposed SEIR) provides updated analysis for changes in the project since the Final EIR 564 was certified in 1998.

The Proposed SEIR has been prepared to analyze and disclose the potential environmental effects associated with the changes of the Revised Master Plan for the expansion of James A. Musick Facility (JAMF).

**Recommended Action:**

- a) Receive staff report and public testimony;
- b) Recommend that the Orange County Board of Supervisors find that the proposed Supplement to EIR 564 for the James A. Musick Jail Revised Master Plan was prepared in compliance with CEQA and County of Orange Environmental Analysis Procedures, adequately describes the impacts of the project, and reflects the independent judgment and analysis of OCSD, and;
- c) Recommend that the Board of Supervisors approve the 2012 James A. Musick Site and Facilities Master Plan.
