# **OC COMMUNITY RESOURCES**

## Orange County Parks Commission Duties and Responsibilities

(O.C. Codified Ordinances Sec. 2-2-19: Paraphrased)

Except as otherwise provided, the Orange County Parks Commission shall be advisory to the Board of Supervisors and to the Director of OC Parks, and shall have the power and duty:

- 1. To recommend to the Board of Supervisors plans and policies for the acquisition, development, maintenance and operation of the harbors, beaches and regional parks of the County;
- 2. On request of the Board of Supervisors, to advise the Board and make recommendations on any matter pertaining to harbors, beaches and regional parks, and any other matters referred by the Board;
- 3. On request of the Director, to advise on any question of administrative policy and regarding any matter to be decided by the Director under this division;
- 4. On appeal from an administrative decision by the Director, to act as a board of administrative review;
- 5. To make such investigations as it may deem necessary in the exercise of its powers;
- 6. To perform the duties and functions of the County Fish and Game Commission assigned by either statute or this code, and consider methods for the propagation and protection of fish and game in the State of California and County of Orange. The Commission shall be advisory body to the Board of Supervisors.

#### IV. DISCUSSION CALENDAR MATTERS (Items A – C)

### A. PETERS CANYON REGIONAL PARK GENERAL DEVELOPMENT PLAN AND RESOURCE MANAGEMENT PLAN

Staff have completed drafts of the General Development Plan and Resource Management Plan for Peters Canyon Regional Park. The draft GDP is a longterm plan that addresses current and future park needs (including parking, trail access, restrooms, and other facilities), operations, and management of the park for ecological and hydrological sustainability. The draft RMP addresses natural and cultural resource protection, fire hazard reduction measures, and requirements of the Natural Community Conservation Plan/Habitat Conservation Plan (NCCP/HCP) amidst impacts resulting from the increased popularity and visitorship of Peters Canyon.

Staff will provide an update on the most recent public workshop conducted in April 2019 and a presentation on the draft GDP and RMP at the Commission meeting.

#### **RECOMMENDED ACTION:**

Recommend that the Board of Supervisors approve the Peters Canyon Regional Park General Development Plan and Resource Management Plan.

# B. TRAILS SUBCOMMITTEE – PROPOSED SECOND QUARTER AGENDA AND GUIDELINES REVISION

An update will be provided on the previous Trails Subcommittee meeting, and an agenda is proposed for the next meeting, expected to be held on June 27, 2019.
