#### **IV. DISCUSSION CALENDAR MATTERS (Item A)**

##### **A. PARK ABANDONMENT AND AUTHORIZATION TO CONVEY LAND – ALISO AND WOOD CANYONS**

The California Department of Transportation (Caltrans) is planning a construction project on State Route 133 (SR-133), which includes safety improvements, undergrounding of utilities, and addition of a bike lane. Park abandonment of an unused portion of Aliso and Wood Canyons Wilderness Park and modification to the premises managed by OC Parks under a Lease with the City of Laguna Beach are needed to facilitate the project.

*Stacy Blackwood, OC Parks Director, provided information and answered Commissioner's questions.*

##### **RECOMMENDED ACTIONS:**

1. Recommend that the Board of Supervisors find that the Corner Parcel at Aliso and Wood Canyons Wilderness Park is not required for County use and approve actions related to park abandonment of the Corner Parcel.
2. Recommend that the Board of Supervisors authorize actions necessary for County staff to approve and execute all real estate instruments to transfer the parcel to a qualifying public entity for reasonable consideration based on the market value for the property's intended use, subject to compliance with County Regional Riding and Hiking Trail policies and satisfaction of Park Abandonment requirements related thereto.
3. Recommend that the Board of Supervisors authorize actions necessary to amend the 2009 Amended and Restated Lease for the Laguna Coast Wilderness Park between the County and the City of Laguna Beach to remove parcels required for a Caltrans project along State Route 133, upon approval of County Counsel.
