OC COMMUNITY RESOURCES

Orange County Parks Commission Duties and Responsibilities

(O.C. Codified Ordinances Sec. 2-2-19: Paraphrased)

Except as otherwise provided, the Orange County Parks Commission shall be advisory to the Board of Supervisors and to the Director of OC Parks, and shall have the power and duty:

- 1. To recommend to the Board of Supervisors plans and policies for the acquisition, development, maintenance and operation of the harbors, beaches and regional parks of the County;
- 2. On request of the Board of Supervisors, to advise the Board and make recommendations on any matter pertaining to harbors, beaches and regional parks, and any other matters referred by the Board;
- 3. On request of the Director, to advise on any question of administrative policy and regarding any matter to be decided by the Director under this division;
- 4. On appeal from an administrative decision by the Director, to act as a board of administrative review;
- 5. To make such investigations as it may deem necessary in the exercise of its powers;
- 6. To perform the duties and functions of the County Fish and Game Commission assigned by either statute or this code, and consider methods for the propagation and protection of fish and game in the State of California and County of Orange. The Commission shall be advisory body to the Board of Supervisors.

Keep it Wild Stewardship Event — Laguna Coast Wilderness Park — Friday, February 4 — 2:30 p.m.-4:30 p.m.

- Join Laguna Canyon Foundation and OC Parks at one of our habitat restoration stewardship events in Laguna Coast Wilderness Park as we learn and work together to create a healthier habitat for the native plants and wildlife that call the canyon their home.
- Depending on the time of year, volunteers will assist with various stewardship activities, including removal of non-native plants, seed collection, and/or planting of native plants.

Wilderness Access Day: Limestone Canyon — Irvine Ranch Open Space — Saturday, February 5 — 8 a.m.–2 p.m.

- Start your weekend off by exploring numerous opportunities found throughout magnificent Limestone Canyon.
- Designated trails will be open for self-guided trail use in OC Parks' Irvine Ranch Open Space.
- Trail routes vary in distance and level of difficulty with choices ranging from easy one-hour walks to strenuous 15-mile cardio treks.
- Whether traveling by feet, hooves or wheels, Wilderness Access Day in Limestone Canyon is a treasure waiting to be discovered by hikers, equestrians and mountain bikers alike.
- Minors, ages 18 and under, must be accompanied by an adult.
- Adult mountain bikers and equestrians are required to wear helmets. Minors are required to wear helmets per state law.
- Inclement weather or fire danger will cause the program to be cancelled.

- Celebrate Irvine Regional Park's 125th birthday all through 2022!
